Regler for deltagelse i Paraden

I Copenhagen Pride tilstræber vi at have så få regler som muligt, så alle kan koncentrere sig om tilstedeværelsen i Paraden og de gode oplevelser.

Politiet m.fl. har dog udstukket regler for hvordan vi alle skal opføre os, når Paraden passerer igennem byen. Det er disse regler som paradeguiden ved siden af jeres gruppe formidler. De vil henvise til reglerne - for jeres egen sikkerhed og for at Copenhagen Pride fortsat får tilladelse til at gennemføre Paraden. Her er reglerne.

OBLIGATORISK PARADEGUIDE

For at kunne deltage i Paraden kræves det, at deltagergrupperne selv stiller med paradeguides:

- Én paradeguide pr. køretøj, som kræver stort kørekort og yderlig én paradeguide, hvis køretøjets sider er 90-120cm høje (grundet særligt vilkår i indhentet dispensation fra Færdselsstyrelsen).
- Én paradeguide for alle grupper med gående - uanset gruppens størrelse - og yderligere én paradeguide for hver 100 gående.

Som en del af Paradens sikkerhed kræves det at jeres Paradeguide(r) tager opgaven seriøst. Det betyder at vedkommende deltager i det obligatoriske informationsmøde, holder sig ædru og parat til at irettesætte de andre i gruppen. Udebliver den udvalgte Paradeguide vil det betyde udelukkelse fra Paraden.

REGLER UNDER PARADEN

- Paradeguidernes og Politiets anvisninger skal følges!
- Det er strengt forbudt at hoppe af eller på køretøjerne eller hænge uden på dem undervejs. Overtrædelse kan medføre øjeblikkelig udelukkelse af køretøjet fra paraden!
- Vær opmærksom på og giv plads til udrykningskøretøjer.
- Paraden tilsidesætter ikke gældende lovmæssig om blufærdighedskrænkelser og lign.
- Musikken fra lastbiler må kun være på et 'akustisk' niveau. Som tommelfingerregel må musikken ikke kunne høres fra vogn til vogn.
- Efterlad ikke affald.
- Det er ikke tilladt at uddele materiale undervejs

MUSIKAFGIFTER

Copenhagen Pride sørger for at betale KODA-afgift for 'båndmusik' under paraden. Medbringer I et liveband, så skal I selv sørge for registrering hos KODA m.v.

Rules and regulations For Participation

Copenhagen Pride strives to maintain as few rules as possible, so people may focus on what is important: Having fun.

The Police and other authorities have dictated some rules which needs to be followed. The Parade Guides next to your group might refer to the rules – this is for your own good and safety and to ensure that Copenhagen Pride get the permissions needed to conduct future parades. These are the rules:

MANDATORY PARADE GUIDE

In order to participate in the Parade the groups must appoint:

- One Parade Guide per vehicle above 3500 kg - and one additional Parade Guide if the vehicle railings are 90-120cm (according to special permission from the Danish Road Safety Agency).
- One Parade Guide for walking groups disregarding the number of participants, and additionally one Parade Guide for every 100 walking participants.

It is essential that the Parade Guide takes the job seriously to contribute to the security; i.e. the Parade Guide is required to participate in the information meeting, keep sober and to reprimanding the others in the group, so safety will not be compromised. If the Parade Guide is not presented the group will be banned for participation.

RULES DURING THE PARADE

- Directions from Parade Guides and Police Officers are to be followed at all times!
- A zero-tolerance policy is enforced against people leaning out over the railing or otherwise climbing around on vehicles. If we observe this, both the vehicle and its occupants will be removed from the parade immediately.
- Be aware of your surroundings and give way to emergency vehicles.
- The parade does not nullify existing legislation on indecent exposure or the like.
- The music volume emitted from trucks may only be at an "acoustic" level. As a rule of thumb this means the occupants on the previous or following lorry must be unable to hear you.
- Don't litter.
- Distribution of material (flyers, for instance) is prohibited.

MUSIC FEES

Copenhagen Pride pays the KODA copyright holders' fee for all taped or digitally stored music that is played during the parade. If you bring along a live band, you will have to make arrangements with KODA yourself. This is not covered by the fee paid by Copenhagen Pride.
